Hilda opened our meeting welcoming our guest, the **Reverend Alan Hamilton** of Killermont Parish Church, Bearsden, who is a pathfinder and advocate of the Church of Scotland's Path of Renewal initiative, in which we had expressed an interest.

Alan opened his address with a series of challenges and short discussion on the future of the Church in Scotland, and the role and potential for a new 'church', for new ways of worship, community leadership and service.

Speaking of the Church in today's world, Alan said ...

- The Church of Scotland as we knew it, in the past, is dead. The world in which we live today would have been alien to Martin Luther, to John Knox ...
- The church is no longer at the centre of the community

Today ...

- We need the right tools for the time
- Change will take time. The church needs to understand the world ... by asking questions of the Lord
- We live in and relate not to one community, but a series of (changing) communities

Speaking of the Path of Renewal initiative, Alan said ...

- It's a movement, not a programme
- The Church is about what congregations are doing
- The only people who can help the Church and our church are 'us' and the Lord
- Different communities ... different congregations ... different things
- We need to respond to this changing world ... shaped by gospel, by friendship, by locality, by the gifts of God's people ... the Path of Renewal make it a reality

Across Scotland there are 40 congregations currently embracing the Path of Renewal approach, and we are currently working to support the next 40 congregations joining us on that path. A path of discipleship, of learning and re-shaping as we go.

The Path of Renewal affords congregations an opportunity to re-focus, away from the 'what we've always done, to what we should do today.

Just as with every renewal process, this one is a 'hearts and minds' thing.

The Kirk Session reverted to its planned business, on this most notable of days, the 500th Anniversary of the Reformation.

Grant Application

I reported at the last Kirk Session meeting that we had received the approval of Presbytery for the proposed fabric repairs to the Church, and that Presbytery had passed our application to the General Trustees. Unfortunately, that was not the case and the matter was referred on to the Fabric Convenor who, following a visit, agreed that the matter be put before the next meeting of the Trustees fabric committee is on 7th November.

lan expressed his hope that our application will be approved at that meeting, enabling him to proceed to obtain tenders and make application to other grant funders.
